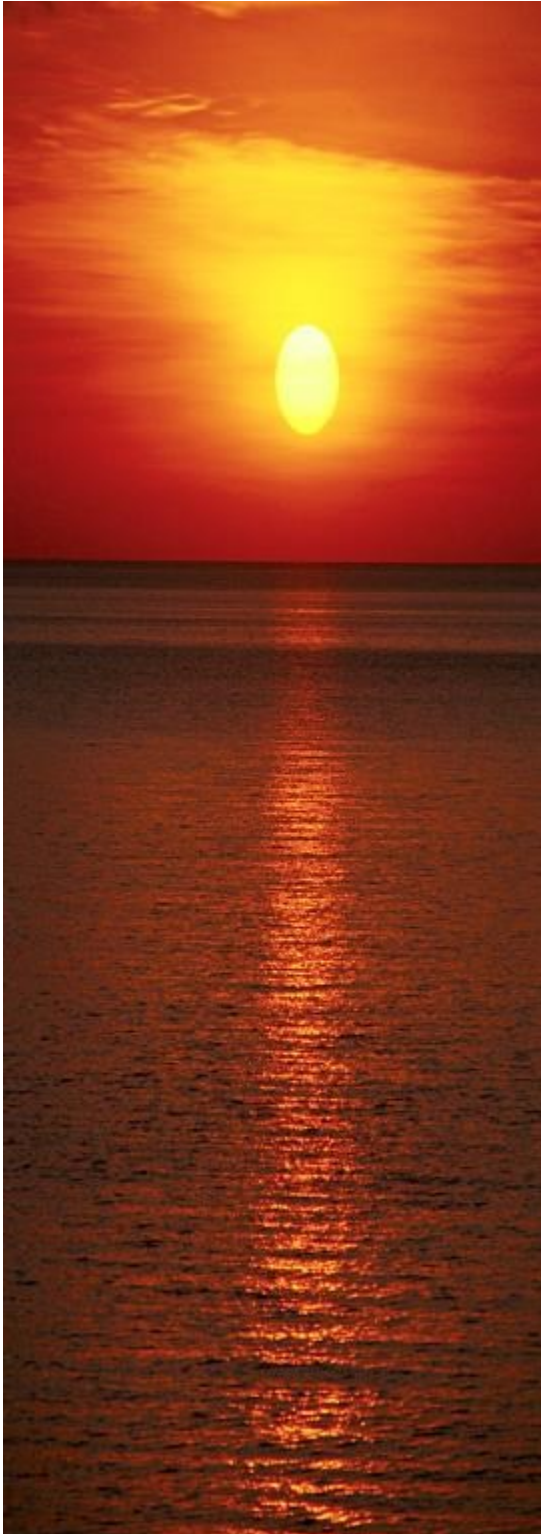


IFC ShortCast

Dear IFC Members,

Recently, IFC sent out a survey to the membership and received some great input from the membership. Many respondents commented that they would like to have an outlet to be able to make meaningful contributions to a charity that aligns with the IFC ideals of sport fishing, conservation of our marine resources and habitats, enjoyment of our local waters.

Many years ago, Islamorada Fishing and Conservations Trust (IFACT) was established by a few of our IFC Board members to raise funds for these aligning causes and for many years IFACT provided scholarships for youth who aspired to have a career in a marine field ranging from a biologist, a fishing captain, or any other such related field. IFACT also aided working captains in their time of need. IFACT raised awareness regarding rules and regulations and provided opportunities for education.

It is clear from the survey results that IFC needs to be a conduit to facilitate IFACT's mission and as a result the IFC Board has entered into a lease agreement with IFACT to provide use and access to our new building for IFACT fundraising efforts and events. In return, the lease provides that IFACT will be responsible for funding a portion of the interior improvements and build out of the new IFC building. To accomplish the build out, IFACT will receive donations from IFC members and the public alike and IFACT will be able to grant legacy naming rights to portions of the new building recognizing those contributions, **As IFACT is a 501C3, these deductions will be tax deductible.**

This arrangement will not impact any IFC member's use of our new facility but rather it will enhance the experience with tournaments and event evenings that will not close the club in its entirety and will be open to any member who decides to participate.

IFC strongly encourages our membership to consider the donation opportunities available through IFACT that will secure them a permanent place for their organization and keep them going forward as the IFC charity of choice. At the same time, these donations are absolutely vital to aid in the completion of our new building and all members are encouraged to participate in these opportunities.
